The Vernon Parks and Recreation Department offers a vacation camp for children in grades K-5 at the Vernon Teen Center (375 Hartford Turnpike)

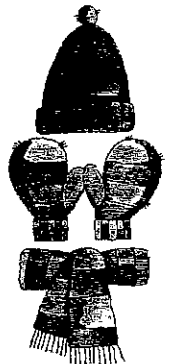
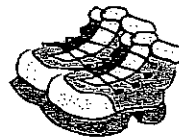
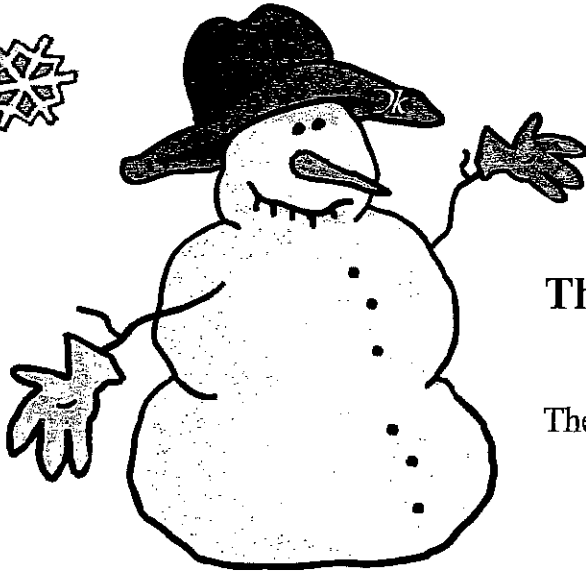
Cost is \$30/day for residents and \$35/day for non-residents
